F. RECOMMENDED ACTION ITEMS/PRESENTATIONS

F.1 2022-2023 Financial Statement and Transfers to/from Accumulated Surplus – Available for Compliance Funds 2022-2023; Superintendent Hutchinson

Superintendent Hutchinson presented a summary of the 2022-2023 Financial Statements. Highlights include an increase in enrolment, increased revenue, and expenditures. Superintendent Hutchinson reviewed the detailed accumulated surplus and the contributing factors.

Mr. Andrew Newman from KPMG presented the Auditor's Report to the Board of Trustees and confirmed the Board's operations and change in financial position for the 2022-2023 school year, are in accordance with the framework required by the Ministry of Education.

- Transfer from the internally appropriated School Budget Carryover fund the amount of \$551,712 which represents the balance of the school budgets that was spent in 2022-23;
- Transfer from the internally appropriated ICT Hardware fund the amount of \$2,897,694 which represents the amount to purchase computer hardware for schools;
- Transfer from the internally appropriated PPE Inventory fund the amount to \$1,023,215 which represents the decreased value of PPE inventory on hand as at August 31, 2023;
- -Transfer from the internally appropriated Sinking Fund Interest Committed fund the amount of \$2,532 which represents the cost of the 2022-23 amortization on the related assets;
- Financial Statements for the fiscal period September 1, 2022, to August 31, 2023."

G.1 Bell Times – Daycares; Superintendent Hutchinson

Superintendent Hutchinson reviewed the information shared to date, regarding the impacts of bell time changes. Superintendent McDonald shared the effect of bell time changes on daycares, as per the survey conducted with Consolidated Municipal Community Managers (CMSM). Daycares anticipate having difficulty staffing before school programs.

Superintendent McDonald shared highlights of the meeting she attended with the City of Cornwall regarding the plans for development of the former Vincent Massey Public School. The project will go through a public consultation before being approved. Other consultations will occur by Senior Administration.
